Eligibility: The Customer Survey Sweepstakes is only offered electronically via the Internet and is open only to legal residents of Arizona, California, Idaho, Montana, Nevada, North Carolina, Oklahoma, Oregon, Texas, Utah, Virginia, and Washington and who are at least eighteen (18) years old at the time of entry and whose address is within an Eighty (80) mile radius from an operating CHEF'STORE located in the United States. Employees of CHEF'STORE ("Sponsor"), Foresee, their respective parent companies, affiliates and subsidiaries, and all advertising, promotion and production agencies, and their immediate family members (i.e., spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each ("Sponsor and Others") are not eligible to enter. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. #### 4. How to Enter:

There are two ways to enter.

- (a) Online Survey: Make a purchase (of any amount) at a participating CHEF'STORE retail location during the Sweepstakes Period and look on your cash register receipt for a survey invitation. Entrants must complete the CHEF'STORE® Survey online at [www.chefstore.com/survey](http://www.chefstore.com/survey) and may take the survey once per Sweepstakes Period. To be eligible, online survey entries must be completed within seven (7) days after the applicable purchase. Survey respondents must enter their 10-digit telephone number at the end of the survey to be eligible for the Sweepstakes.
- (b) Mail in Entry: On a postcard (no smaller than 3.5 x 5 inches and no larger than 4 x 6 inches), handwrite your complete name, mailing address, phone number and age and mail with proper and sufficient postage to 1800 Blankenship Road | Suite 250| West Linn, OR 97068. All mail-in entries must be original (no photocopies or other reproductions) and must be received during a Sweepstakes Period. All postcards must be mailed individually.

Limit: Each entrant may enter one (1) time, per household and per email/mail address/telephone number during the Sweepstakes Period. Multiple entrants are not permitted to share the same email address. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's Sweepstake entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder. 5. Sweepstakes: Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Sponsor will randomly select the potential Sweepstakes winners, from all eligible entries on or around the last day of every Sweepstakes period. Entries will not be carried over from one Sweepstakes Period to the next Sweepstakes Period.

6. All potential winners are subject to verification by Sponsor, whose decisions are final and binding in all matters related to the promotion. An entrant is not a winner of any prize, unless and until entrant's eligibility, and the potential sweepstakes winner have been verified and entrant has been notified that

verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any entry that occurs after the system has failed for any reason is deemed a defective entry, is void and will not be honored.

7. Verification of potential winners: receiving a prize is contingent upon compliance with these official rules. The potential sweepstakes winners will be notified by mail, email, or phone. Before being declared a prize winner, the potential prize winner will be required to verify eligibility. Entries will not be carried over from one Sweepstakes Period to the next. Each winner is solely responsible for any and all federal, state, provincial and local taxes that apply to the Prize. No cash or other substitution of the prize is permitted. CHEF'STORE reserves the right to verify and determine eligibility in its sole discretion. Release: By participating in this promotion and/or by receiving any prize, participant and/or winner agrees to release and hold harmless Sponsor and others (as defined above) from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property (including but not limited to damage to participant's computer), arising out of participation in the promotion and/or receipt or use or misuse of any prize.

10. The jams rules for selection of an arbitrator shall be followed, except that the arbitrator shall be experienced and licensed to practice law in California. All proceedings brought pursuant to this

paragraph will be conducted in Los Angeles County, California. The remedy for any claim shall be limited to actual damages, and in no event shall any party be entitled to recover punitive, exemplary, consequential, or incidental damages, including attorney's fees or other such related costs of bringing a claim, or to rescind this agreement or seek injunctive or any other equitable relief.
