Cost Plus World Market Customer Survey Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Cost Plus World Market Customer Survey Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Cost Plus Inc., ForeSee Results, Inc., HelloWorld, Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. 4. How to Enter: There are two (2) ways to enter.

a. <u>Complete an on-line survey after a purchase</u>: During the Promotion Period*, after you make a purchase, follow the links and instructions found on your store receipt to complete a short on-line survey about your purchase experience and then complete and submit the on-line registration form, including a valid home mailing address. You must complete the survey within seven (7) days of your purchase. Once the survey is completed and if you confirm you would like to enter the Sweepstakes, you will automatically receive one (1) entry into the applicable Monthly Entry Period drawing. Surveys received after August 31, 2015 (even within seven (7) days of purchase will not be including in any drawing).</u>

*You will only receive a request to participate by completing an online survey for purchases made through August 24, 2015. You may participate by the method described below through the end of the Promotion Period.

b. <u>Enter without purchase or completion of a survey</u>: Visit <u>https://survey.foreseeresults.com/costplus_ss</u> and complete the online registration form, including your name, address, email address. You will receive one (1) entry into the applicable Monthly Entry Period drawing.

Limit: Each entrant may only enter five (5) times per Monthly Entry Period by any combination of entry methods. Multiple entrants are not permitted to share the same email address. Any attempt by any

entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified.
